is approved as a final land development plan ("Final Plan") consistent with the Towamencin Township Subdivision and Land Development Ordinance conditioned upon completion/satisfaction of all of the provisions and conditions set forth in the following:

- 1. CKS Engineers, Inc. second final plan review letter dated September 4, 2025;
- 2. Bowman review letter dated September 5, 2025;

BE IT FURTHER RESOLVED, that the Final Plan approval is conditioned upon the following:

- 1. Compliance with all conditions and requirements set forth in the preliminary plan approval resolution (Resolution No. 25-28) pertaining to the land development.
- 2. All public/site improvements associated with the land development shall be constructed in conjunction with the Project.
- 3. Providing an extended school zone along Snyder Road to include the additional property on the eastern side of the site provided that the extension is approved by the Pennsylvania Department of Transportation,
- 4. Providing a crosswalk with appropriate warning signs/devices at the intersection of Bridle Path Drive and Sumneytown Pike in accordance with the recommendations in the letter from Bowman dated August 13, 2025, subject to specific location and configuration approval by the Pennsylvania Department of Transportation and the Montgomery County Department of Roads and Bridges.
- 5. Entering into a land development agreement in a form satisfactory to the Township Solicitor.

- 6. Entering into a written agreement addressing the perpetual maintenance responsibilities for the stormwater management facilities in a form satisfactory to the Township Solicitor.
- 7. Entering into a Landscape Covenant in a form satisfactory to the Township Solicitor, providing for the proper maintenance and, if needed, replacement of required landscaping.
- 8. Providing the following easements in a form satisfactory to the Township Solicitor:
 - a. Proposed sidewalk/trail easement along Sumneytown Pike,
 - b. Proposed grading and landscape easement on the adjacent property for the North Montco Technical Career Center, and
 - c. Proposed drainage easement for the watercourse within the property.
- 9. Submission of a copy of the approval from the Montgomery County Conservation District for the proposed Erosion & Sediment Control Plan and an NPDES Permit for Discharges Associated with Construction Activities from the Pennsylvania Department of Environmental Protection.
- 10. Submission of appropriate permits for the culvert extension at Sumneytown Pike from the Pennsylvania Department of Environmental Protection and the Montgomery County Department of Roads and Bridges.
- 11. Submission of a copy of the approval from the Pennsylvania Department of Transportation for the proposed improvements along Valley Forge Road (S.R. 0363)
- 12. Submission of a copy of the approval from the Montgomery County Department of Roads and Bridges for the improvements along Sumneytown Pike.
- 13. Submission of a copy of the approval from North Penn Water Authority for proposed modifications to the water system.
- 14. Submission of the Final Record Plans to the Township for recording at the Montgomery County Recorder of Deeds office.
- 15. Submission of an electronic copy of the Final Record Plans to the Township.
- 16. Provisions for all necessary as-built drawings for the Project.

BE IT FURTHER RESOLVED, the following provision of the Towamencin Township Stormwater Management Ordinance is being waived as follows:

 Section 132-13.C.6 with regard to the requirement that the stormwater collection systems be designed to produce a maximum velocity shall be 15 feet per second is hereby waived for the pipe run connecting to the storm sewer in Sumneytown Pike subject to approval from the Montgomery County Department of Roads and Bridges.

WHEREAS, the above-noted waiver is granted contingent upon compliance with the information presented on the above-noted final land development plans;

No waiver from any applicable provisions of the Towamencin Township Subdivision and Land Development Ordinance, the Towamencin Township Engineering Standards, the Towamencin Township Stormwater Management Ordinance, the Township Driveway Ordinance, the Towamencin Township Grading and Excavating Ordinance and the Township Streets, Curbs, and Sidewalks Ordinance are intended to be granted by virtue of this final plan approval unless such waiver requests are specifically granted herein. Any proposed design or construction on the plans which would otherwise require a waiver by the Board of Supervisors, and which has not been specifically granted hereby must be addressed for approval to the Board of Supervisors.

This approval is further conditioned upon the acceptance of the conditions contained herein by the applicant and his/her signifying his/her acceptance of these conditions by signing a copy of this Resolution and returning it to the Township.

In the event that said execution of the resolution is not delivered to the Township office by noon, October 22, 2025, it shall be deemed that the applicant does not accept these conditions and any approvals conditioned upon their acceptance of the conditions are revoked and the application shall be considered denied for the reasons set forth above and as authorized in Section 508 of the Municipalities Planning Code.
