### REQUIRED DOCUMENTATION FOR PERMIT TO SOLICIT

The applicant must provide the following documents when applying for a solicitation permit:

- Non-expired, valid driver's license or state issued identification.
- Pennsylvania criminal record check completed within **7 days** of application date.
  - Criminal record checks may be requested online through Pennsylvania State Police at <https://epatch.pa.gov>
- \$100 fee payable by cash, check or money order (checks and money orders should be made out to Towamencin Township Police).

There is no fee for non-profit or charitable organizations.

Permits are valid for **30 days**. After 30 days, permits expire and all applicants must repeat the application process, including submitting a background check and paying the applicable \$100 fee.

Failure to provide valid documentation or providing documentation containing erroneous information may result in delay or denial of the application.

**Failure to adhere to township ordinances may result in immediate revocation of solicitation privileges for you and the company you are representing, as well as facing possible citations issued to you and your company by Towamencin Township Police.**
